Community Development Director Blanca explained that these amendments are minor, keeping up to date with changes in laws and regulations. This change would require the permit to be obtained through the State.

Scott Allison of 5903 Milan rd. voiced his concerns with changing regulations. Director Blanca explained again that regulations are not changing, but rather the entity in which the permit for firework sales needs to be obtained.

Fiscal Officer Comments

- Payments for the period of June 22nd July 4th totaled \$\$797,253.21. This includes payments to Rumpke for the dumpsters used at Clean Up Day, Best Equipment for repairs and maintenance to Public Works Equipment, Premier Home Professional for Community Development Grant work, Strawser Construction for crack sealing and micro surfacing, and PROTX Tactical for police vests.
- Motel Tax for the month of May totaled \$119,216.81, bringing the Township up to \$498,162.24 for the year. With the difference YTD being down by only .07% the next few summer months will be more telling on whether we will bring in more revenue than last year.
