## **Fiscal Officer Comments**

- Payments for the period of February 24<sup>th</sup> through March 20<sup>th</sup> totaled \$1,226,180.48. This includes payments to STRYKER for the fire department equipment services agreement, RFC Contracting for fire station services, Flock Group for the safety camera renewal, DMC Technology for Microsoft 365 licenses, Sharpnack Chevrolet for a vehicle in the Community Development department, OHM Advisors for the Perkins Ave engineering match, and Erie Conservation District for the 2026 Stormwater Program.
- Motel tax for the month of February totaled \$87,232.70, bringing the collection for the year at \$113,511.09, close to a half of a percent higher than 2025.
